DECISION OF THE COUNCIL NO 4 OF 2015

(Adopted at the eighth meeting on 12 November 2015)

AMENDMENT TO THE APPENDIX TO ANNEX Q TO THE CONVENTION

AIR TRANSPORT

THE COUNCIL,

Having regard to the Member States' endeavour to regularly update the Convention in order to take account of developments under the Agreement on the European Economic Area and the bilateral Agreements of 21 June 1999 between the Swiss Confederation on the one hand and the European Community and its Member States on the other,

Having regard to Article 53(3) of the Convention, empowering the Council to amend the Appendix to Annex Q to the Convention,

Having regard to the recommendation of the Committee on Air Transport to the Council to amend the Appendix to Annex Q (Air transport) to the Convention, ref. 15-6274,

DECIDES:

- 1. The Appendix to Annex Q to the Convention shall be amended as follows:
 - a) The following texts shall be deleted from point 3 (Air Safety):

'No 2042/2003

Commission Regulation of 20 November 2003 on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks.

No 707/2006

Commission Regulation of 8 May 2006 amending Regulation (EC) No 2042/2003 as regards approvals of a limited duration and Annexes I and III.

No 376/2007

Commission Regulation of 30 March 2007 amending Regulation (EC) No 2042/2003 on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks.'

'No 1056/2008

Commission Regulation of 27 October 2008 amending Regulation (EC) No 2042/2003 on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks.'

'No 127/2010

Commission Regulation of 5 February 2010 amending Regulation (EC) No 2042/2003 on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks.

b) The following texts shall be deleted from point 5 (Air Traffic Management):

(To be applied as from the entry into force of the relevant Swiss legislation, but from 1 January 2012 at the latest).'

No 441/2014

Commission Implementing Regulation of 30 April 2014 amending Regulation (EC) No 29/2009 laying down requirements on data link services for the single European sky.

c) The following shall be inserted in point 3 (Air Safety) after the reference to Commission Regulation (EU) No 319/2014:

Commission Regulation of 26 November 2014 on the continuing airworthiness of aircraft and aeronautical products, parts and appliances, and on the approval of organisations and personnel involved in these tasks.'

d) The following shall be inserted in point 4 (Aviation Security) after the reference to Commission Implementing Decision 4054/2014:

Commission Implementing Regulation of 6 February 2015 amending Regulation (EU) No 185/2010 as regards the screening of cabin baggage.

No 561/2015

Commission Implementing Decision of 6.2.2015 amending Commission Implementing Decision C(2010) 774 as regards the screening of cabin baggage.

No 984/2015

Commission Implementing Decision of 19.2.2015 amending Commission Decision C(2010) 774 laying down measures for the implementation of the common basic standards on aviation security in respect of air cargo and mail transported into the Union.'

e) The following shall be inserted in point 5 (Air Traffic Management) after the reference to Commission Implementing Regulation No 716/2014:

'No 2015/310

Commission Implementing Regulation of 26 February 2015 amending Regulation (EC) No 29/2009 laying down requirements on data link services for the single European sky and repealing Implementing Regulation (EU) No 441/2014.

No 970/2014

Commission Implementing Regulation of 12 September 2014 amending Regulation (EU) No 677/2011 laying down detailed rules for the implementation of air traffic management (ATM) network functions.

No 1028/2014

Commission Implementing Regulation of 26 September 2014 amending Implementing Regulation (EU) No 1207/2011 laying down requirements for the performance and the interoperability of surveillance for the single European sky'

- f) Points d, e and f under Regulation (EC) No 550/2004 of the European Parliament and of the Council in point 5 (Air Traffic Management) are renumbered as points c, d and e.
- 2. This Decision shall take immediate effect.
